

## REPORT ON PAGE TITLES

Page titles are important. It is the first viewable text appearing in a site's source code, and it is displayed in search engine results, browser tabs, the browser menu bar and it shows up by default on every printed page. Having a long page title may influence search engine rank or display, but it can also get cut off in smaller displays, whether on the screen or in print.

Following are examples of how page titles appear in context online.
